² Normal Merits: The Committee voted against 1 normal merit for an Academic Coordinator. The case involved an unintentional one year deferral, which the Committee found to be unacceptable based on the candidate's excellent record of performance. Therefore, the Committee recommended an acceleration. The final decision was in agreement.

Administrative Issues

- The ASPC has concerns about the timeliness of merits in the administrative series'. Several actions seem to be deferred because of administrative error. The candidates appear to be unaware of the merit schedule and therefore are overlooked in the review cycle. This leads to a large number of retroactive requests, which delays the candidate's merit and unnecessarily complicates committee review.
- This year, the Committee received at least one appointment after the announcement that the candidate had been hired. This is of grave concern to the ASPC as it undermines the process and can lead to unnecessary conflict if the Committee doesn't support the candidate. The ASPC requests that this situation be avoided in the future.
- Once again, the Committee notes that on-line review of actions is essential to the
 efficiency of the review process and requests that this process be implemented
 as soon as possible.
